- The next Law Meets Engineering lecture topic is *Latent Defects; Frequent Sources of Litigation. How to Minimize Risk*. It will be taking place on February 25 at 5:30 pm in EV 2.260. The previous lecture given by Ms. Kathy Baig, President of OIQ, was a great success with more than 200 people in attendance.
- The Teaching Day on Decolonizing the engineering and computer science curriculum was held on February 18.
- Last night the Royal Society of Canada celebrated the class of 2019 at an event hosted by Concordia
 University. Two members of Concordia University were welcomed to the Society: Dr. Guylaine
 Beaudry, Vice-Provost of Digital Strategy and University Librarian, and Dr. Alice Jim, Professor in the
 Department of Art History.

5. Associate Dean Remarks

Ali Akgunduz

- Following up from the CEAB meeting on Ottawa, beginning next year the number of Accreditation
 Units assigned to engineering students will drop from 1950 to 1850 which will lead to about a three
 course reduction in our curriculum requirements. Coupled with the Cégep increase in credits from
 225 to 450, a gain of three or four courses, we'll need to make some fundamental changes in our
 engineering programs in the next few years.
- At this time of year there is always an increase in the number of Academic Code of Conduct cases submitted, particularly by invigilators. Professors are requested to consult with invigilators regarding any infringements of the code of conduct in their exams to ensure appropriate measures are taken.
